REFUNDS PEST CONTROL COMPANIES

PETALING JAYA: The Subang Jaya Municipal Council (MPSJ) has returned to 22 pest control firms RM3,000 deposits which the High Court had deemed were collected illegally.

Its president Datuk Adnan Ikhsan said the council had been making the refunds since Thursday to abide by the court's Aug 12 decision to declare null and void the council's policy requiring all pest control firms in the municipality to be registered and for a RM3,000 deposit to be paid before firms could conduct business.

The application was brought by the Pest Control Association Malaysia (PCAM) and Stopest (M) Sdn Bhd, of which PCAM president Ang Tan Loong is founder.

Adnan told *theSun* last Thursday that of 43 firms registered with MPSJ, 22 paid the deposit when they registered last year. "We didn't collect the deposit from the 21 firms which registered with us this year," he said.

When contacted, Ang claimed that he had to threaten the council with contempt of court action before it agreed to honour the court ruling.

He said both parties agreed that Stopest would be registered on MPSJ's panel; there would not be a deposit and an occasional review of pest control rules and policy.

"We waited patiently for our firm to be reinstated into the panel as per the agreement but it did not happen and when I asked a councillor, he said he heard the legal adviser declare the court's order as unofficial," said Ang.

However, legal department director Anita Abdul Jalil refuted this: "I said no such thing. There must have been some miscommunication. Immediately upon the extraction of the judgment, I prepared the council to fulfil the order."

However, Ang who claimed his company was victimised for blowing the cover on the illegal pest control consortium said Stopest was last on the list. He said Stopest should be placed higher as it was the first to register, although it refused to pay the deposit.

DOSH Officers visit & audit in Pest Control Operator's (PCO) Premise

Of late the Association understands from its members that DOSH Officers have been to their premise for audit. There were many requirements and compliance from DOSH officers. The more prevalent requirement to be observed by PCO is the USECHNN 2000 (Use & Standard of Exposure of Chemicals Hazardous to Health Regulations). Pesticides is listed as chemicals hazardous to health under this Section.

As such, the Chemical Hazard Risk Assessment (CHRA) is to be carried out by a DOSH Registered Assessor. However, If the fees for each chemical is, say, RM800, and if you are using 30 types of chemicals, then one has to spend RM24,000 for the DOSH Assessor.

CHRA may be a required law under OSHA. However, from our experiences, CHRA is more appropriate for the factory environment where workers are exposed to chemicals throughout the work day. In the case of the pest control operations, seldom are there workers doing fogging or chemicals spraying 8 hours a day, 6 days a week. Furthermore, almost all the residue spraying methodologies involved water diluted chemicals which will be evaporated after awhile.

Most of our members who were visited by DOSH officer raised the above concern to the Association.

On 23 Dec.2009, a dialogue between PCAM & DOSH was arranged. Here is an extract of our President's reply to the Director General, DOSH after the meeting.

"As an association responsible and committed to the betterment of our pest control industry and whilst endeavoring to co-operate with all relevant authorities, we would wish to implore and appeal to your good office to consider :-

1) Permitting us to comply with generic CHRA instead of each individual pest control company adhering to the above regulations. The main reason is that more than 90 % of our members are Small and

medium Enterprises (SMEs) and the cost of assessment for all the chemicals will be detrimental to our survival. Furthermore, most if not all of us apply similar pesticides and the methods or standard of Operations are as defined vividly by the label, registered and approved by the Pesticides Board of Malaysia.

2) Delaying the implementation of USECHH Regulations, 2000 to our members as some of us had already been issued with compliance orders and summons from the various state enforcers of DOSH and extending the timeframe for us to comply.

With due and sincere respect to you, Dato Ir Dr Johari we shall await your prudent advice and without denial, your regulations stipulated under OSHA 1994 are in effect beneficial to the safety and protection of all parties directly and indirectly involved and we shall attempt our utmost desire to abide truthfully without prejudice."
